1. (U) Chronology of Highlights

- (a) 4-15 March - made first deployment to the combat area.
- (b) 17-21 March - earned sixth meritorious conduct ashore award in Hong Kong, BCC during a port visit.
- (c) 28 March-4 April - participated in Fleet Service Mine Test 1-58.
- (d) 5-7 April - assisted in search and rescue mission for a downed aircraft in the Okinawa area.
- (e) 13-18 May - made second deployment to the combat area.
- (f) 28 June-22 July - made third deployment to the combat area.
- (g) 6-18 December - made fourth deployment to the combat area.

2. (U) Basic Narrative

a. USS SURFBIRD (ADG-383), under the administrative command of Commander Mine Force, U.S. Pacific Fleet and the operational command of Commander Seventh Fleet, is attached to Commander Mine Flotilla ONE. The ship is homeported in Sasebo, Japan, and was commanded during 1968 by Lieutenant Commander Edward Morgan WILLIAMS, U.S. Navy.

b. The mission of the ship is to provide limited mobile degaussing facilities and services with the designed tasks of establishing and operating degaussing ranges in forward areas, providing facilities and services for inspection, calibration and adjustment of shipboard degaussing equipment, providing facilities and services for depersing of steel hull ships and submarines and to be capable of limited self-defense.

c. The first of January found the ship in Sasebo, Japan providing degaussing services to TG 70.5 and the Japanese Maritime Self-defense Force (JMSDF). She sailed on 19 February and after a brief fuel stop at Subic Bay, Republic of the Philippines on 25 February, arrived at Sangley Point, Republic of the Philippines on the same day. From 26-29 February, the ship provided degaussing services to units of Mine Division 71. On 1 March, the ship got underway for Cam Rahn Bay, South Vietnam arriving on 4 March. Degaussing services were provided there for 8 MSB's until 9 March, when the ship left for Danang, South Vietnam arriving 10 March, after providing degaussing services for another 3 MSB's at Danang, the ship departed on 15 March for a port visit to Hong Kong, BCC. During this visit from 17-22 March, the ship earned the meritorious conduct ashore award for having no shore patrol violations by the crew during the visit. This was the sixth consecutive award earned. On 23 March the ship got underway for Tsoying, Taiwan arriving on 23 March. At Tsoying, degaussing services were provided to the Republic of China Navy until 26 March, when the ship left for Buckner Bay, Okinawa. At Buckner Bay, the ship participated in Fleet Service Mine Test 1-68 until 5 April and also received her Operational Readiness Inspection from Commander Mine Flotilla ONE during the period. On 5 April, the ship got underway for position 27-10 North 150-05 East to assist in a search and rescue mission for a downed Navy F-3 Orion. The area was departed on 7 April after two days of search with negative results. Arriving in Sasebo on 8 April, degaussing services were provided for units of TG 70.5 and JMSDF until 8 May, when the ship departed for Danang, arriving on 13 May. After providing degaussing services for 8 MSL's from USS EPPING FOREST (MCS-1) at Danang until 16 May, the ship returned to Sasebo, arriving on 20 May. Degaussing services were again provided for TG 70.5 and JMSDF until 3 June, when the ship departed for Chinhae, Korea, arriving on 4 June. Degaussing and deperming services were provided to the Republic of Korea Navy until 8 June, when the ship returned to Sasebo, arriving the same day. Until 12 June, the ship remained in upkeep in Sasebo and then sailed for Danang arriving 18 June. Degaussing services were provided for the MSB's until 25 June, when the ship left for Cam Rahn Bay, arriving the next day. After providing degaussing services to the MSB's at Cam Rahn Bay until 1 July, the ship left for Vung Tau, South Vietnam arriving the same day. Degaussing services for MSB's and other indigenous craft were provided until 22 July, when the ship departed for Sattahip, Thailand, arriving on 24 July. Degaussing services were provided there for the Royal Thailand Navy and units of Mine Division 94 until 11 August, when the ship departed for Bangkok arriving the same day. After a three day port visit, the ship departed Bangkok on 14 August for Sangley Point arriving on 19

August. There, degaussing services were provided for a unit of TG 70.5 and some units of the U.S. Coast Guard until 29 August, when the ship sailed for Sasebo, arriving on 2 September. Upkeep and degaussing services were provided there for units of TG 70.5 and TG 70.8 until 11 November, when the ship departed for Chinwa, arriving the next day. After providing degaussing and deperming services to the Republic of Korea Navy until 17 November, the ship left for Sasebo, arriving the next day. From 18 to 30 November, the ship remained in Sasebo for upkeep and to provide degaussing services to units of TG 70.5 and TG 73.5. She then departed for Danang arriving on 6 December where degaussing services were provided for the MSB's until 8 December, when the ship sailed to Vung Tau. Arriving on 10 December, degaussing services were provided for 7 MSB's until 15 December, when the ship departed for Sasebo, arriving on 23 December after a fuel stop at Cam Rahn Bay on 16 December. From 23 to 31 December, the ship remained in Sasebo providing degaussing services to units of TG 70.5 and a unit of TG 73.5.

d. During the month of October, the ship received an armament conversion with the addition of two 20mm twin mounts. One was located on the main deck forward and the other on the 01 level aft.


e. Command attention was given to the ship's messing level during the year, and a recommended change to the enlisted distribution plan level, peacetime allowance and wartime complement was submitted on 31 October. This change was designed to best fit the ship's requirements for the effective conduct of operations.

f. ARFBIRD spent 299 days in port during the year, 131 on which degaussing or deperming operations were conducted. The ship spent 168 days out of home port traveling 17,977 miles in transit.

g. A total of 141 ships were ranged during the year using the portable degaussing range carried on board or the permanently installed facilities in Sasebo. A total of 4 ships were also depermed using the equipment carried on board. A breakdown by country of these totals is as follows:
